Father Andrew has requested funds to have a heating upgrade at the school. This will upgrade the heat valves and make heating more efficient and regulated. Quote for this was \$6,125. **Request 2nd Quote**

We previously approved funds, ½ cost split with Mens Club, for replacing the East side entrance doors to school. Doors are heavy and have had incidents of kids fingers getting caught between. Mens Club DID NOT approve to cover their requested portion. Can HSA pay the full amount to have doors replaced? Total \$5,000. **Run request in church bulletin. Ask for 2nd collection at mass**
